Casa Legislativa em 10.05.2024, a Concessionária informa que não há histórico de atendimento ou/e apresentação de documentos comprobatórios da posse do imóvel como por exemplo o contrato de locação do imóvel em face do Sr. Jeferson junto à BRK requerendo a troca de titularidade. Complementarmente, junto ao ofício em epígrafe não foi enviado qualquer comprovação referente ao contrato de aluguel em nome do Sr. Jeferson.

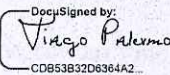
